APOLLO & FAMILY PARKS SPRING COMPETITION

TERMS & CONDITIONS

By entering the Apollo & Family Parks Spring Competition (the "Competition"), you are agreeing to the following Terms and Conditions.

STANDARD TERMS

- 1. Information on how to enter and the Prize form part of these Terms and Conditions.

 Participation in the Competition is deemed acceptance of these Terms and Conditions.
- 2. Apollo Motorhome Holidays can vary these Terms and Conditions at any time and will take effect upon publishing on the Family Parks website (www.familyparks.com.au).

ELIGIBILITY

- 3. Entrants must be a citizen or permanent resident of Australia or New Zealand.
- 4. Entrants must be over 21 years of age and have a valid credit card.
- 5. Employees (and their immediate families) of the Promoter and agencies associated with the Competition are not eligible to enter. WINNER

- 13. There is one (1) winner (the "Winner") over the Competition Period.
- 14. The Winner will be selected by a panel of judges selected by the Promoters. The Winner will be chosen within seven (7) days of the close of the Competition Period.
- 15. The Winner will be the entrant whose description of "Which Family Park would you most like to visit on your adventure and why?" is judged to be the most creative and original and who satisfies the eligibility requirements as set out in these Terms and Conditions. - 16. The judging panel's decision is final and the Promoters will not enter into correspondence regarding the result.

 - b. any theft, unauthorized access or third party interference;
 - any entry or prize claim that is late, lost, altered, damaged or misdirected (whether
 or not after their receipt by the Promoters) due to any reason beyond the
 reasonable control of the Promoters;
 - d. any variation in prize value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by a winner or entrant; or
 - f. use/taking of a prize (independent financial advice should be sought as tax implications may arise as a result of accepting the Prize).
